As the youngest of four in a Vietnamese refugee family growing up in a working-class American neighborhood, her home resonated with Vietnamese traditions and values even as English became their spoken language. Immersing herself in this duality honed her skills in active listening, nuanced communication, and respectful engagement with diverse perspectives-attributes invaluable to her role as a mediator.

In 2023, MyKhanh founded Shelton ADR, where she channels her experience and expertise into mediating today's complex employment disputes. She has deep subject matter expertise and comprehensive knowledge of federal and state case law and statutes. MyKhanh is adept at managing the emotional and legal aspects of sensitive employment matters. She keeps her fingers on the pulse of how workplace dynamics, relationships and language have evolved, expectations have changed, and how juries process and value those considerations.
